## SURFACE PREPARATION

UNTREATED SURFACES. On new, clean, dry and firm surfaces, no prior prep work is required. In case of needing improved consistency or adhesion, seal and prime with a coat of Akril-80 (42.115).

PAINTED SURFACES. If existing paint is in good condition, product can be applied directly. for deteriorated paint, eliminate loose and flaking paint, and any dust or dirt.

For gloss or satin surfaces sand lightly to remove gloss to improve surfae adhesion and eliminiate substrate surface tension.

Before proceeding with the paint job, carry out a test on a small area to verify the finish and surface adhesion as well as product compatibility between coats.

### PATHOLOGIES.

Mould contamination. Wash thoroughly and desinfect using Junoclean Prod.Code 760.180. Rinse with water and leave to dry out completely.

Saline efflorescence (Saltpeter). Brush vigourously, clean and neutraize with a mixture of Chloridic acid or Zonc Sulphate (10%) and water. Rinse with water and leave to dry out completely.

### GENERAL RECOMMENDATIONS

Stir contents well ensuring complete homogenization.

Apply on consistent, clean and completely dry surfaces, free from efflorescence (saltpeter) and mould.

Do not apply on surfaces with temperatures below 5°C, nor on excessively warm surfaces.

APPLICATION METHOD. Brush or roller. For improved results, apply two coats, first one diluted with 10% D-45 Thinner (Prod.Code 50.017) and the second coat undiluted.

CLEANING. Clean up stains and work tools using D-45 JUNO Universal Thinner (Product Code 50.017).

## OBSERVATIONS

Avoid topcoating with waterbased emulsions before fully curing (10 days), as the water content in the paint will bring out old stains.

### SAFETY AND ENVIRONMENT

Solvent based product must be applied ensuring proper ventilation and by applying necessary protection measures.

Avoid sources of ignition. Minimize product waste by estimating the amount needed, taking into account the m<sup>2</sup>, porosity and texture of the substrate.

Store surplus paint in a ventilated, dry place. The container must be clean and of adequate size for the quantity of surplus left overs. Close containers carefully and keep upright to avoid spills.

Keep the containers away from frost, high temperatures and direct exposure to the sun. Recover unused product for new use to reduce environmental effects. Do not eat, drink or smoke while preparing and applying the product.

Surface preparation and application operations must be carried out with appropriate safety measures. For more information consult the Material Safety Data Sheet.

In case of contact with eyes, rinse with plenty of clean water. Keep out of the reach from children. Do not discharge into drains or the environment.
